Agreement amending the Memorandum of Agreement for the provision of assistance in developing and modernizing the civil aviation infrastructure in Afghanistan of August 20 and 27, 2003. Signed at Washington and Kabul October 21 and December 1, 2010. Entered into force December 1, 2010.
