Agreement concerning the sharing of confiscated proceeds and instrumentalities of crime related to United States v. One Helicopter, et al. and United States v. One Parcel, et.al, aka the Benitez Brothers case. With addendum. Signed at Santo Domingo November 14, 2011. Entered into force November 14, 2011.

Agreement regarding the status of United States personnel who may be temporarily present in Panama. Effected by exchange of notes at Panama City November 7 and December 1, 2011. Entered into force December 1, 2011.

Agreement amending the agreement of June 21, 1995 concerning measures for the protection of classified military information. Signed at Bucharest December 14, 2011.

Memorandum of understanding for the cooperative production of the Evolved Sea Sparrow Missile (ESSM). With annexes.
