* Categories involving atomic energy, nuclear weapons and movement of nuclear material have been reorganized into three new categories: **Atomic Energy**, which will comprise all civil aspects of nuclear power (fuel, research, peaceful nuclear cooperation, IAEA, safety, etc.); **Nonproliferation**, which will include trafficking, prevention and detection, test bans and nonproliferation, and **Weapons**, which will include storage and safety, monitoring and control, and cooperative threat reduction.
